



ABSTRACT

The dissertation used historical narration analysis to address the roles of the church in the quest for socio-political and economic restructuring of Nigeria. The work first analyzed the Concept of the Church, Concept of National Transformation, Challenges of Socio-Political and Economic Restructuring of Nigeria towards National Transformation. Nigeria and Political Structure, The need for Socio-Political Restructuring of Nigeria, Nigerian overheated religious conflicts and threat to disintegration: its effects on socio-political restructuring of Nigeria. The work also explored the Need for Peaceful Co-Existence towards Socio-Economic and Political Development of Nigeria. Muslims Vis-À-Vis Christians Conflicts and how it hinders Socio-Economic and Political Development of Nigeria Implications of the Nigeria Insecurity Situation (Boko Haram) towards sustainable socio-economic development. The conclusion of the study is that the center of Nigeria's socioeconomic problem is the failure of leadership and as such any effort to liberate the country from its present condition must be political in nature. However, maintaining the ecclesiastical paradigm that the Church as a body should not get herself involved in partisan political activism, the paper outlined some possible functions by which the Church in Nigeria can contribute immensely towards the desired liberation.
