2. **Peer Review Process:** All submitted manuscripts undergo a rigorous peer review process. This enhances objectivity and maintains the quality of published papers.
3. **Data Availability:** ULM encourages authors to share data supporting their research findings, promoting transparency and replicability.
4. **Open Access:** ULM provides an open-access publication model, allowing unrestricted access to research outputs. This aligns with the journal's mission to disseminate knowledge widely and encourage scholarly dialogue.

5. Manuscript Preparation: Detailed guidelines for manuscript preparation are provided on the journal's website. Authors should adhere to formatting requirements, including structure, length, and citation style.

7. Articles should be typed in Microsoft Word using 12 font size (Times New Roman), and they should not exceed 6000 words in single line spacing with an abstract of 150 to 200 words. Authors can use any of these referencing styles, APA (7<sup>th</sup> Edition) or MLA (7<sup>th</sup> Edition).
